

How to Apply for a Visa to IRAN:

- 1- Visit <https://evisa.mfa.ir>
- 2- Under the “*Individuals and Travelers*” section, click on “*Apply Now*”.
- 3- Carefully read the “*Important: Before You Start*” section on the right side of the page.
- 4- Click on “*Start a Visa Application*”. Choose your visa type and follow the steps to complete the application.
- 5- Upon completing your application, a “*Visa Submission Notice*” will be generated.
- 6- Print the “*Visa Submission Notice*”.
- 7- Mail the following items to the Interests Section of the Islamic Republic of Iran in Washington, DC:
 - Printed copy “*Visa Submission Notice*” or “*Visa Grant Notice*”
 - Visa Request Form (Page 5 of this form)
 - Applicant’s passport
 - Money order in US Dollars, payable to the “**Embassy of Pakistan**”.

Total amount should include:

- Non-refundable Visa Application Fee (refer to the fee table below),
- Non-refundable Insurance Fee of US\$13 per visa application, and
- Non-refundable Processing fee/Postage US\$40 per package (Prepaid envelopes are not accepted)
- Mark “**VISA SECTION**” clearly on the package with a marker
- For urgent visa request mark “**URGENT VISA PROCESS**” clearly on the package with a marker.

Important Notes:

- Passports must be valid for **at least six months**.
- Only applicants currently residing in USA and Canada may apply through this office.
- Applying with the United States, United Kingdom, and Canada passports must only apply through travel agencies or their host in Iran.
- Applicants applying with non-USA or non-Canadian passports must provide a copy of their valid immigration status document.
- Incomplete e-visa applications will be rejected.
- Visa applications that remain inactive for one month will be systematically declined.
- All fees paid are non-refundable and non-transferable, even if the visa application is rejected.
- The visa will only be issued electronically, and a copy will be sent to the email address provided on the E-Visa application.
- Visas for husband and/or children (above 18) of Iranian citizens will only be issued upon approval by the Ministry of Foreign Affairs. For children under 18, parents must complete the attached form and send it with the required documents.
- Applicants from Canada should not send Cashier's Checks from "Scotia Bank" or "Western Union".
- Each package should ONLY include documents of the applicant and their immediate family (if any).
- Each package must ONLY contain documents pertaining to the applicant and their immediate family (Spouse and Children).
- The average processing time for visa issuance is 10 business days, while urgent processing takes 2 business days from the date of document receipt. Processing times may increase if documents are incomplete.

- Applicants must enter Iran within **45 days** of visa issuance and may stay for the period indicated on their visa, starting from arrival.
- **It is recommended not to purchase tickets or finalize travel arrangements until your visa has been issued, as this office is not responsible for any potential losses resulting from delayed visa issuance.**
